Please note that I represent Arthur Jay Lewis regarding correspondence that he received from you, dated April 22, 2016, on behalf of your clients, Paul Alli and Mega Billion, Corporation, Ltd.

Please understand that your clients have provided you with incomplete and/or erroneous information as it pertains to the alleged transaction with regards to six (6) Certificates of Deposit. Please allow this letter to directly address and hopefully clarify any confusion you may still have.

Simply put, my client has met his obligations with respect to completing the vetting process of the alleged certificates in question. In fact, the copies of the alleged six (6) Certificates of Deposit were presented to Wells Fargo Bank. Unfortunately for all parties involved, they were denied for being fraudulent. To confirm this, Wells Fargo followed up with a letter to Mr. Lewis's company, Creative Concept Financial Strategies. I have enclosed that letter for your review. I shall quote from it:

We confirm the Certificates of Deposit presented for redemption in a Wells Fargo location, of which you provided photocopies, are not authentic, therefore, we are not able to negotiate these items for payment. We regret any inconvenience.

Please contact the United States Secret Service with the original certificate copies for further assistance in regards to investigation of the counterfeit items.

Please note that my client has acted accordingly and turned the fraudulent documents over to the Secret Service.

In summation, the facts are these:

There are no authentic Certificates of Deposit. There are no alleged bank accounts at any respective bank holding any CDs or any value derived therefrom. No certificates have been redeemed. These alleged certificates were deemed fraudulent by the bank at which they were presented for redemption. These fraudulent CDs have been turned over to the proper authorities, and Mr. Lewis has contacted both the Secret Service and the Federal Bureau of Investigation. After receipt of your letter, he contacted the FBI once more.

I expect that this shall be sufficient to inform your clients that no further harassment of my client on this matter will be tolerated. Any further contact from you or your clients, regarding fraudulent certificates of deposit will simply be forwarded to the same federal authorities for review.
